

Champions Reserve Alteration Application

An application requesting approval for any alteration which occurs outside the exterior walls of the dwelling <u>MUST BE ACCOMPANIED BY THE FOLLOWING FOR CONSIDERATION</u>:

- ✓ Copy of the lot survey with the alteration(s) drawn on it
- ✓ Legible sketch and/or drawing indicating location, size, and type of construction
- ✓ Contractor information
- ✓ Color swatches
- ✓ Pictures
- ✓ Materials
- ✓ Detail description of alteration (Page 2 of form)
- ✓ Non-Refundable \$25.00 Application Fee (Check or money order payable to
- Meritus Associations)
- ✓ Other pertinent information as required

It is recommended that you review the Declaration of Covenants, Conditions and Restrictions provided for a complete description of your responsibilities regarding Architectural Review requirements and submittals.

Please mail your completed application to our office at 2005 Pan Am Circle, Suite 120, Tampa, Florida 33607, Attn: Architectural Review. You will be notified in writing with the decision made by the Association and/or the Architectural Review Board. Pursuant to the Declaration of Covenants, Conditions and Restrictions of your Homeowners' Association, your application process may take thirty (30) to forty-five (45) days. Please plan accordingly.

If approval is granted, it is not to be construed to include approval of any County or City Code Requirements. A building permit from the appropriate building department is needed on most property alterations and/or improvements. It shall be the sole responsibility of the owner to determine whether a permit is required. The Association and/or the Architectural Review Board shall have no liability or obligation to determine whether such improvement, alteration or addition complies with any applicable law, rule, regulation, code or ordinance.
